

**RESOLUTION NO. 2012 - 02**

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCOA BEACH, FLORIDA, AMENDING GARBAGE, WASTE AND TRASH FEES; AND PROVIDING FOR AN EFFECTIVE DATE.

**WHEREAS**, Garbage, Waste and Trash Fees are adopted by Resolution.

**NOW, THEREFORE, BE IT RESOLVED** by the City Commission of the City of Cocoa Beach, Florida, as follows:

**SECTION 1.** The above recitals are true and correct and by this reference are hereby adopted by the City of Cocoa Beach.

**SECTION 2.** The following schedule of fees shall be amended:

**Fees charged**

**(a) Residential:** Residential shall include single-family residences; multi-family buildings of eight (8) living units or less:

(1) Curbside: Total on Bill ~~\$11.67~~ \$12.10 per month per unit  
Curbside service includes garbage, yard trash, and recycling service

(2) Rear yard service:  
Total on Bill ~~\$15.48~~ \$15.73 per month per unit  
Rear yard service includes garbage, yard trash, and recycling service

(3) Handicapped residents receive rear yard service at the curbside rate of - ~~\$11.67~~ \$12.10 per month per unit

(4) Multi-family dwelling units using mechanical containers:

Garbage - ~~\$2.75~~ \$2.85 per cu. yd. per month

Yard trash - ~~\$0.84~~ \$0.87 per res. unit/month

Recycling - ~~\$1.94~~ \$1.98 per res. unit/month

(5) Multi-family dwelling units, using cans - same as residential units of eight (8) or less. (see (a)-(1) or (a)-(2) (which ever applies)

**(b) All Commercial:**

(1) Commercial - Mechanical containers: ~~\$3.54~~ \$3.64 cu yd/month

(2) Loose commercial garbage or trash, collected within cans ~~\$7.40~~ \$7.67 cu yd./month

(3) A minimum charge for any commercial account is ~~\$22.48~~ \$22.98 month

**(c) Charges:** The charges set forth herein shall may be included on in the City of Cocoa Beach, Florida, Sewer and Garbage bill or other billing system.

**SECTION 3: INTERPRETATION.** In interpreting the body of Section One of this Resolution, the following rules of interpretation shall be utilized:

(1) Terms underlined are additions to existing text.

(2) Terms stricken through are deletions from existing text.

**SECTION 4:** Effective Date: This resolution and rates adopted shall become in full effect in January 5, 2012.


