A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COCOA BEACH, FLORIDA, ENCOURAGING LOCAL ARTISTS TO DISPLAY THEIR ARTWORK IN CITY BUILDINGS; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, talented artists live in the City of Cocoa Beach and in the surrounding communities; and

WHEREAS, the City Commission recognizes that the exhibition of fine art plays an important role in the cultural development of a community and provides aesthetic pleasure to the general public; and

WHEREAS, it is the wish of the City Commission to encourage local artists to display their artwork in City buildings where it can be viewed by both the City's residents and the many visitors to our community.

NOW, THEREFORE, BE IT RESOLVED by the City Commission of the City of Cocoa Beach, Florida, as follows:

SECTION 1. The City Commission encourages local artists to display their artwork in City buildings.

SECTION 2. The City Commission authorizes the City Manager to contact the Space Coast Art Festival and other art organizations to encourage the display of artwork in City buildings.

SECTION 3. This Resolution shall become effective immediately upon its adoption.
